- Establishing a continuing professional competency program for all members.

The MCA networks with many other professional associations, regulatory organizations and government which helps position chiropractors as valuable contributors in Manitoba's integrated health care system.

Self-regulation is a privilege granted in the public interest and for the public good. The MCA is committed to governing in a manner that respects this privilege.

ABOUT CHIROPRACTIC CARE

Manitoba chiropractors are experts specifically trained to diagnose the underlying cause and recommend treatment options relating to the spine, musculoskeletal and nervous systems.

Chiropractors are trained to relieve pain, restore mobility, increase function, and prevent re-occurrence so Manitobans can get back to leading healthy, active lives.

Chiropractors are also trained to provide advice to patients on activities of daily living, work, healthy lifestyle choices, injury prevention and nutrition.

And, with 294 chiropractors practicing province-wide, the MCA is committed to ensuring that Manitobans have access to, and the opportunity to experience, the positive outcomes of chiropractic care.

We were also pleased to welcome the new government appointed lay member, Mr. Doug Nanton. Mr. Nanton has considerable experience in working with Associations and has proved to be wise counsel in the few short months he has been on the Board.

The Board engaged in a number of different governance activities to strengthen our Association including:

- Board governance training
- Updated by-laws to reflect the current realities
- Implemented a board meeting policy to ensure transparency

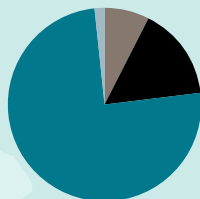

Processing Time (Days)

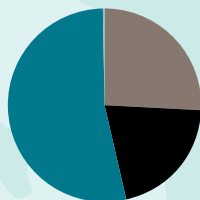

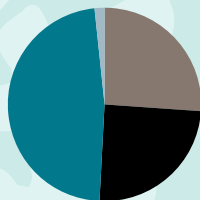
To Forward to Investigation Chair (Escalation)

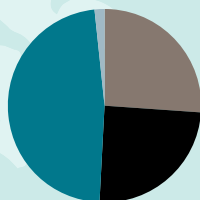
From IC to Closure

REGISTRAR'S REPORT

DR. AUDREY TOTH, D.C., CAFCI

It remains my honour to serve as MCA Registrar despite an unprecedented, relentless, and challenging year. The COVID-19 pandemic required the MCA to be agile, immediately adapting to unanticipated public health orders mandated to ensure public safety. Our regulatory processes have been repeatedly leaned upon since the pandemic onset. The MCA expeditiously approached such matters with fair and balanced procedures and protocols for the benefit and protection of the public.

During the first and second phases of COVID-19, chiropractors remained open, providing essential care and then emergent/urgent care. Information was circulated regularly of the ever-changing requirements related to clinic occupancy, enhanced sanitation, social distancing, removal of soft touch items, and, eventually, PPE. Members were cordial during spot inspections that were promised in the Notice to Profession published on March 31, 2020. We are happy to report that nearly all the spot inspections for compliance were conducted with favorable outcomes. Most members were welcoming and cooperative during inspections and many surprised us with their creative, innovative implementations to make enhancements more palatable to the public, such as the virtual waiting area that had patients wait for a text while in their cars.

I am honored to have been a support when we had the answers and could help immediately with stressful situations. The Board of Directors was regularly advised of the impact that our membership was experiencing and how swiftly and competently so many had adapted to the "new normal." I recently heard a comment that being a regulator during COVID-19 has been like "trying to

build a plane while you are flying in it." While I do agree with the statement, I would be remiss to not underscore the cooperation and professionalism that I have repeatedly encountered in so many of our colleagues, especially after they had received a "stay at home" isolation order from Public Health.

On the licensing front, CCEB exams were cancelled, forestalling integration into the work force by incoming graduates. Applications were considered on individual merits. To preserve clinical competencies, conditional licenses (with supervised practise) were issued until exams were completed.

Of final note, this year was marked by a note-worthy increase of member vs. member advertising complaints. Given the time that the MCA had to devote on these matters, the MCA has subscribed to an automated "Webscraper" program which will monitor on-line advertising and marketing content. In the coming year, automatic reports will be generated, and members will be provided the opportunity to reduce their regulatory risk by immediately complying with the MCA advertising standards.

125 YEARS OF CHIROPRACTIC

AWARDS/APPOINTMENTS

Dr. Steven Passmore

Canadian Chiropractic Association - Researcher of the Year

Dr. Steven Passmore was named the 2020 Researcher of the Year by the Canadian Chiropractic Association.

The award recognizes an investigator whose contribution has improved the clinical treatment of chiropractic patients and has demonstrated outstanding research achievements and advancement of new knowledge in their field of expertise.

Since 2011, Dr. Passmore has been researching the impact of chiropractic care at Mount Carmel Clinic—an inner-city community health centre that serves those with the highest unemployment rate and lowest average family income in Winnipeg. As a result of his findings, the Manitoba government has funded this chiropractic service beyond the pilot phase.

Dr. Gerald Olin

World Federation of Chiropractic - Appointment to the Board

On May 4, 2020, Dr. Gerald Olin was appointed to the Board of the World Federation of Chiropractic. Following two years of dedicated service to the CCA as the Board Chair, Dr. Olin stepped down in June 2020 to serve in his new role.

INCORPORATION STATISTICS

On November 8, 2018, new provincial legislation was passed allowing for professional incorporation. Since that date, the MCA has issued 43 Chiropractic Corporation permits.

MCA ACCEPTS OFFER ON OFFICE

In late December 2020, the MCA received an unsolicited offer to purchase our existing office building at 987/989 Portage Avenue. After a brief negotiation period, the Board of Directors accepted the offer to purchase with possession of the building set for March 1, 2021.

The MCA originally purchased the building in 2019 to develop it into a home our members could be proud of. Staff temporarily moved into the smaller suite while a plan to renovate the larger suite was created.

Due to the age of the electrical and mechanical, an in-depth financial analysis and estimated renovation budget was completed which determined that it was not feasible to complete the project within the original budget, especially when potential rental income for the suites was factored in.

Upon receipt of the offer to purchase, the MCA once again undertook a detailed financial analysis. After negotiations with the buyer, the final purchase amount allowed the MCA to recoup a significant portion of the costs expended over the last two years on the purchase, repairs and expenses related to planning the renovation.

Once the new owners take possession, the MCA will lease the existing space on a month-to-month basis while we look to lease a new space. The MCA Board of Directors is committed to finding appropriate space for staff so that they can carry out the association and regulatory functions, minimizing the costs to the MCA while providing easy access to the MCA for members.
